Notes/Meeting Summary

- Key Takeaways & Discussion by Agenda Topic
 - Background and Updates:
 - PHIL (facilitator) asked for additional feedback on the charters by Friday, 3/31, noting that our team will add more details to the charter from this meeting.
 - PHIL will send out the updates to CPI partners.
 - PHIL shared relevant tools: "Readiness Roadmap,"



PHIL reviewed the Aim Statement, Key Drivers, Support Strategies, and Change Ideas

Updates from PHC:

- Reminder: If you are engaged with a member in hopes of enrolling them, please ensure they are on your files as soon as possible so that we can document them internally at PHC. This will also help PHC catch any members whom multiple providers are outreaching.
- Regarding members being outreached by multiple providers, we are also working with Collective Medical on a solution to allow a Flag to indicate instead of Enrolled in ECM, it will indicate they are assigned an ECM Provider and if they are in the process of enrolling or are enrolled.
- PHC has updated the MIF Template Columns to match the RTF in order to try to unburden our providers with completing their required report.
- o CPI Partner requested a mechanism (ex. Newsletter) from PHC to learn and share their updates
- O Question from CPI Participant: "You said that the CM upload will be done more often do you have an idea on the shorten timeframe? Every week, every two weeks? etc."

Breakout Groups by County: Review Change Ideas

- PHIL used a Jam Board to prioritize the proposed Change Ideas.
- This process included sharing thoughts about the Change Ideas and prioritizing the change ideas from highest to lowest priority.

Group discussion: Agree on Prioritization of Change Ideas as a Southwest CPI Region

- The group recognized the diversity in reasons as to how/why a Change Idea is more prioritized than another.
- The group uplifted the importance of equity and support for organizations serving historically marginalized populations as a priority focus.
- There was not sufficient representation from sectors and counties to identify Change Ideas
 - PHIL facilitator asked about the existing collaboratives CPI Participants engage with to promote collaboration and synchronism with existing efforts.

 PHIL provided updates on new CITED funding training, our TA Marketplace training, and upcoming facilitator dates.

Identified Gaps in CalAIM/ECM/Community Supports Service Delivery

- When asked where the organization is on the <u>Readiness Roadmap</u>, CPI participants shared the following:
 - Roadmap stop 1- "What are ECM and CS?": 2 Participants
 - Roadmap stop 2- "It's good fit, how do I get started?": 4 Participants
 - Roadmap stop 3- "Roadblock!": 1 Participant
 - Roadmap stop 4- "I have a contract for ECM and CS!": **0 Participants**
 - Roadmap stop 5- "We are facing challenges": 2 Participants
 - Roadmap stop 6- "We are making it work, but..." 6 Participants
 - Roadmap stop 7- "Quality care as a result!" 3 Participants

Identified Successes & Challenges Experienced by Participants

 Some CPI Partners did not seem to fully embrace PHIL's Change Ideas, bringing forth the opportunity to refine them to be more concrete and direct. The Change Ideas are not clear as to whom they will directly affect (ex. CBO, County, FQHC, outsourced support agency).

Lessons Learned & Best Practices Identified

- o PHIL may have to shift the aim statement and drivers to be more concrete.
- PHIL needs to find opportunities to leverage existing collaboratives and roundtables to avoid duplication of work and resources.
- Solutions and transformation in ECM and Community Supports will not occur without additional context and a systems approach to the barriers experienced by multiple sectors and without a shared vision with the MCP.

• Summary of Complaints & Grievances

- For-profit providers working in the ECM/CS area of service can cause divides between local providers, the MCP, and the State.
- CBO networks as a solution is concerning for small CBOs who do not have the ability to manage a
 contract. This comes from a concern about the lack of clear guidelines on what will is possible under the
 guidelines and restrictions between the MCP and DHCS.
