2024 AIM Statements

Northwest CPI

Improve quality and increase providers contracted for ECM and Community Supports by 25% in 2024. Increase the # of Medi-Cal members receiving these services by 211%

Southwest CPI

Improve quality and increase providers contracted for ECM and Community Supports by 25% in 2024.

Increase the # of Medi-Cal members receiving these services by 100%

The Population Health Innovation Lab (PHIL) will facilitate the collaborative aim by supporting CPI participants along the Readiness Roadmap, encouraging an effective integration of Enhanced Care Management (ECM) and Community Supports services into the local Medi-Cal system.

Readiness Roadmap:

Created in 2023 to help anchor CPI participants in the CalAIM implementation journey, the "Readiness Roadmap" was developed to visualize the journey to implementing new Medi-Cal benefits with Managed Care Plans. With guidance from local experts, the Readiness Roadmap includes local, state and national tools and solutions to guide and assist organizations at any step in their journey.

In 2023, participants' movement along the Roadmap was used as a measurement for the CPI. In 2024, the Roadmap was updated to reflect that progress and link organizational progress to the CalAIM Ecosystem of Care.

Why the Update?

Through ongoing engagement with the Northwest and Southwest Collaboratives, the Population Health Innovation Lab (PHIL) has learned that both collaboratives aim to expand their care ecosystems through partnerships, particularly with local trusted organizations. Steps eight through ten introduce this focus on care coordination while also aligning with the long-term goals of increasing access to and utilization of CalAIM Enhanced Care Management (ECM) and Community Supports.

To address some of the implementation challenges, PHIL offers a multi-pronged approach to providing support to organizations, counties, and the region. This multi-pronged approach includes the following strategies for ECM and Community Support Expansion:

Capacity Building

Technical Assistance offered to CPI organizations

Training opportunities to address challenges

Collaborative Systems Improvement

Foster cross-county systems solutions across all regional stakeholders, including the Managed Care Plan

Relationship and Network Building

Networking opportunities (including monthly CPI meetings) will address siloes and support the establishment of regional collaboration.
